### **ADMISSION**

- A) Admission to the above mentioned course is governed by the provision of University Regulation & Bar Council of India.
- B) A candidate whose conduct & character are not satisfactory shall not be considered for admission.

### **ELIGIBILITY FOR ADMISSION**

- A. Any candidate who has passed Bachelor degree/ Master Degree/ other equivalent degree of Recognized University in any discipline shall be eligible for admission to the three years LL.B. semester Course.
- B. A candidate who fulfils the above requirement shall have obtained not less than 45% of aggregate marks in case of General category and 40% of aggregate marks in case of S.C & ST Category.

### **DURATION OF PROGRAMME:**

The duration of the course shall be of three academic years consisting of six semesters (each year two semesters).

## **EXAMINATION PROCESS**

The Semester Examinations will be conducted by the university. The first, third and fifth semester examination will be held in the month of November and second, fourth and sixth semester examinations in the month of April.
