ADMISSION

- A) Admission to the above mentioned course is governed by the provisions of Madhusudan Law University, Cuttack & Bar Council of India, New Delhi.
- B) A candidate whose conduct & character are not satisfactory shall not be considered for admission.

ELIGIBILITY FOR ADMISSION

- A. Any candidate who has passed Bachelor Degree/ Master Degree/ other equivalent degree recognized by Madhusudan Law University/ UGC in any discipline shall be eligible for admission into Three year LL.B. (CBCS) Course.
- B. A candidate who fulfils the above requirements shall have to obtain not less than 45% of aggregate marks in case of General Category and 40% of aggregate marks in case of Scheduled Caste and Scheduled Tribe Category.

DURATION OF PROGRAMME:

The duration of the course shall be of three academic years consisting of six semesters (each year two semesters).

SELECTION PROCESS

According to merit, basing on the marks of qualifying Examination.

EXAMINATION

The End Semester Examinations will be conducted by the Madhusudan Law University. The first, third and fifth semester examination shall be held in the month of December and second, fourth and sixth semester examinations in the month of June. There will be also a Mid – Semester Examination for each semester.
